You are invited to bid on the marked pine and hardwood sawlog timber on the following described land owned by the GAYLORD L. WALKER TRUST and VICTORIA LEE WALKER HUBER and located in Columbia County, Arkansas:

This is to be a bulk sale with bids made in lump sums separately for pine and hardwood sawlogs and a total lump sum for the entire sale, as shown on the attached bid form. None of the timber will be sold separately. Payment will be due upon signing of the timber deed.

Severance tax will be paid by the purchaser.

The successful bidder will be allowed <u>two years</u> in which to cut and remove the timber conveyed in this sale.
