### 5,113.11 Acres, more or less LEGAL DESCRIPTIONS LISTED BY PACKAGE

The estimated timber volumes are based on a timber inventory performed in August, September and October, 2019 and January and February 2016 by Neill Forestry Consultants. Appropriate growth has been added to the 2016 volumes to arrive at the estimated timber volumes shown:

# ESTIMATED TIMBER VOLUMES LISTED BY TRACT AND PACKAGE

These volumes cannot be guaranteed and each bidder is expected to make his own volume determination. Stock and Stand Tables are available upon request.

This sale consists of 48 separate tracts in five (5) separate Packages. The land has been managed for the production of pine sawtimber on the majority of the land, but there are approximately 403.23 acres of pure bottomland hardwood. The majority of the property is uneven-aged stands, along with a few tracts of pine plantation. Most of the pine tracts have had the hardwood removed and they have been sprayed with chemical herbicide to eliminate the hardwood competition.

The majority of these tracts are currently under hunting lease agreements. Lease fees will be prorated and paid to the new owners, if they wish to continue the leases. All information for the hunting leases will be provided to the new owners at the time of closing.

Package 1 is 1,100.71 acres, more or less. This property is located on the stateline approximately 6 miles southwest of the Three Creeks community.

Package 2 is comprised of 430 acres, more or less in five separate tracts. Three of the tracts are located north of Lisbon and two of the tracts are located east of Marysville and north of Hwy. 82.

Package 3 is comprised of 2,044.64 acres, more or less in 23 separate tracts. These tracts are located in the southwest portion of Union County, south of Hwy. 82 and west of Hwy. 167.

Package 4 is comprised of 1,152.99 acres, more or less in 13 separate tracts. These tracts are located in the east portion of Union County east of Hwy. 167.

Package 5 is comprised of 384.77 acres, more or less in 5 separate tracts. These tracts are located in the east portion of Union County north of Hwy. 82 and east of Hwy. 167.

Upon acceptance of a bid, a formal Contract of Sale, with a deposit in the amount of 5% of the purchase price, will be executed between the successful bidder and the Sellers within seven business days.
